I, \_\_\_\_\_ hereby agree that the dog mentioned above is being adopted by me solely as a pet for myself and family. I understand this means I have no breeding rights. This warranty/contract is also non-transferable should the dog be rehomed. Our dogs are never allowed to be given up to a shelter/rescue or laboratory facility. If your dog needs to be rehomed please contact us.

I agree that the puppy **must be spayed or neutered** by the time the puppy turns **10 months** of age and I will email/text proof to Erica's Doodles. If I fail to uphold this, I will owe Erica Bikneris \$50,000 dollars for a breeding dog. If for any reason you decide not to have the dog fixed by the **10<sup>th</sup> month** PRIOR AUTHORIZATION MUST BE GIVEN BY ERICA'S DOODLES TO EXTEND THIS BEYOND THE 6<sup>TH</sup> MONTH. If you do not receive prior authorization and do not have the puppy fixed by the **10<sup>th</sup> month**, Erica's Doodles has the right to request a bond to be given until proof of fixing has been provided or we retain the right to enact our rights and have owner relinquish the puppy. If for any reason the original owner decides to rehome the dog Erica's Doodles has to be notified prior to original owner relinquishing their rights to a new home. If puppy is returned to Erica's Doodles within 3 days buyer will receive a credit or replacement but no cash/check back depending on circumstances of return.

I understand that Erica's Doodles guarantees that at the time of delivery, the dog is in good health. I have three (3) days from the time of receipt of dog to have dog examined by a veterinarian. Any request to return the dog to the seller for a full refund must be made within this time period and only be requested should the dog prove to be sick upon arrival having life

threaten illness which means puppy will die!! I understand that this guarantee will be terminated immediately if the dog is not examined within the allotted time

A health Warranty against all life altering genetic diseases is provided for three years if fed Life's Abundance non-grain free food. The puppy will have a 2 year health warranty if fed other kibble that contains grains. Should a genetic disease be discovered during this time which will greatly shorten the life of, or greatly alter the quality of life of the dog. Erica's Doodles will give the adoptive parents a replacement puppy from Erica's Doodles for equal value from the next litter, Erica's Doodles will not require Buyer to relinquish said dog when obtaining a replacement.

I understand that a warranty for Hip Dysphasia is provided for two years after the date of birth. This warranty will be terminated should the dog be allowed to become overweight or developing joints be over stressed at any point during the warranty period. If any hip problems are noticed, I will have my vet submit my dog's x-ray to the Orthopedic Foundation for Animals (OFA) for their evaluation and I will send Erica's Doodles a copy of the report. Should the dog be found to have severe crippling Hip Dysphasia, within the first two years, the buyer must provide Erica's Doodles with proof. We reserve the right to confirm the results before a replacement. If the dog has full breeding rights we provide a different warranty

I further agree to maintain this dog in good health, provide routine preventative health care including, but not limited to, inoculation, internal and external parasites, and preventative medication. I understand that veterinary records must be provided to Erica's Doodles if I am requesting a replacement. I understand that if any of the above preventative care has not been provided, the health warranty will be void. If dog has been fed Grain Free food and develops DCM health warranty will be voided. **If given Simparica Trio, Nexguard or Bravecto for Heartworm, Fleas and Ticks and said Dog develops any Neurological issues this contract is nil and voided. These products according to the FDA have been known to cause seizures and other neurological disorders.**

I agree to maintain the dog in a humane environment and to properly train and care for the dog. I understand that Erica's Doodles strongly recommends permanent identification by tattoo or microchip. Erica's Doodles gives permission to be listed as an alternate in the contract or

microchip registration information.

I understand that my deposit is non-refundable. I agree to pay the adoption fee to Erica's Doodles to help cover the current owner's expense of raising and caring for the dog. I understand that Erica's Doodles requires that the puppy be paid in full at time of puppy choosing/pickup.

The Buyer is responsible for all medical expenses associated with the treatment of intestinal parasites if puppy is diagnosed even if puppy has parasites present when sent home. Erica's Doodles follows strict protocols for prevention of Giardia and Coccidia, unfortunately as hard as we try to stick to our protocols sometimes it will happen. Buyer also is acknowledging that they will **NOT** be responsible for medical expenses related to umbilical Hernias, improper bite, puppy ingesting foreign objects at new buyer's home, removal of dew claws and microchipping.

I understand that Erica's Doodles reserves the right to first pick out of any litter, for their breeding program. The selection process is first come, first serve; first deposit gets first pick of litter, second deposit gets second pick and so on. Final picks must be chosen by or before the week the puppies turn 6 weeks old. We require that the puppy is paid in full at time of pick up, **if settling the final balance using Pay Pal: we need final payments to be received 4 days prior, and buyer will also be responsible for adding a 4% fee to remaining balance.** We do occasionally sell our puppies to breeders. If you are purchasing a pet, that means NO BREEDING RIGHTS.

I hereby understand and agree that under no circumstances shall Erica's Doodles be liable to the buyer or to any third party for any consequential, incidental, or special damages resulting from or in manner related to the dog. Upon receipt of puppy all veterinary care and its associated costs are the sole and exclusive responsibility of me.

I understand that when shipping is required, it is at my expense. All puppies will have first shot, wormed, and will be accompanied by a veterinary health certificate if being shipped by air. The shipping fees include air fare, shipping crate, health certificate, and travel to the Airport; a 1 hour drive each way. I understand that Erica's Doodles also offers a puppy nanny at an additional cost if requested. The puppy nanny will be with my new puppy on the flight and

meet me at the airport upon pick up. I agree that if a puppy must be returned, all shipping and transportation costs are at my expense.

It is very important to continue the vaccinations and worming schedule for your puppy and don't forget annual boosters after that, the puppy will need follow-up vaccination, worming, flea control, rabies vaccination and heart worm prevention as recommended by your vet. The dog must be owned by the original owner and must have your contract of sale. As the Breeder/Seller I certify that the dog/puppy is free from illness and defects. Although we do our best to prevent it, we do not cover treated illness includes coccidia and giardia.*
